Rules:

Participants must be between the ages of 12 & 18 years.

Participants ages 12 to 14 must be accompanied by a parent or responsible adult.

Participants 15 and older are not required to have a parent attend but we do encourage parents to come along.

For safety, all participants must wear 50% Blaze Orange clothing the day of the hunt.
